Certificate (in original) of address in India of applicant issued by authorized signatory of employer on employer's letter head mentioning the PAN of the employer + Copy of PAN card for the PAN mentioned in the employer's certificate. One can apply for PAN by submitting the prescribed PAN application to the authorized PAN agency of the district or through online submission to NSDL along with 2 face-photos, ID proof, address proof and fee. In case of Re-print (re-issue), a photocopy of the old PAN is also required.

1.3 Documents to be enclosed along with PAN application Form NRI is required to submit the copy of passport (alongwith PAN application Form) as proof of identity. He is also required to submit any of the following documents (alongwith PAN application Form)as proof of address: a) Copy of passport; or

Form NRIs who are Indian citizens have to apply for a PAN by filling Form 49A, while NRIs with citizenship of another country need to fill up Form 49AA. These forms can be accessed, filled and submitted online through the websites of UTIITSL and NSDL.

However, NRIs need to provide specific documents while applying for a PAN, which is specific to them. Form: NRIs who are Indian citizens have to apply for a PAN Card by filling Form 49A. However, NRIs with citizenship of another country require to fill up Form 49AA.

However, a passport is considered to be a mandatory proof of address for NRI applicants.

How to Get Aadhar Card for NRI if You Are Non-Resident Indian?

Non-Resident Indian (NRI), who are India Citizens can get PAN Number by applying PAN Card for NRI. Only photocopies of the applicant's India passport along with proof of address is required. The passport must be valid at the time of application. Aadhaar is not required to apply for PAN Card as an NRI.

However, when applying for a PAN, NRIs need to include other documents which are unique to them. Type NRIs who are Indian citizens must apply for a PAN by filling out Type 49A , while NRIs with citizenship of another country must fill out Form 49A.
